SKY CANNON USER AGREEMENT

This unit (Skycannon Model SC180; Serial# 0902 TSUS 539) is owned and operated by St. Vincent Scouts. User agrees to protect the unit from damage or theft while under user's control ~ ordinary wear and tear excluded, and to provide a power source of 110 volts, 10 amps within 75 feet of use (normal household circuit with no unusual power loads from other sources). User shall not adjust the position, timer, or any controls, including the off/on switches, unless specifically authorized to do so, as follows:

User shall be responsible for all cost of repair and or replacement if damage or loss occurs during the period of time that the unit is signed out to the user. It is agreed that the cost of replacement is currently \$8,500.00. Please note: improper use can shorten bulb life. Premature bulb failure can happen if the unit is turned on, and then turned off in less than two full minutes. Bulb replacement cost is approximately \$800.00. There is a meter included with the machine to measure time of use. Usual bulb life is 1000 hours. If bulb fails due to any reason other than misuse or abuse by user, then St. Vincent Scouts will refund that portion of the user fee (on a pro rata basis) that is unearned due to the failure. This shall be the only remedy user shall have in the event of failure or other non-performance, all other incidental and consequential damages being specifically excluded. A new bulb was installed at 0.0 hours the most recent new bulb was installed at _____ hours.

Rates for usage are set for each use, depending on length of actual run time projected, delivery time and place (mileage charge is \$1.00 per mile each way from the St. Vincent Scout Lodge, but may be waived for short trips), setup difficulty, multi-day use, and down time between uses. Generally, the minimum fee is \$50.00 per day or \$20.00 per hour of actual use, whichever is greater, with discounts provided for use of 3 nights or more or regular use of less than 2 hours per night on multi-day uses. A down payment is required, with the balance due upon pickup. If billing is necessary after pick-up, an additional charge of \$50.00 shall be due. If not paid in full within 30 days of last use, then a per diem charge of \$10.00 per day shall be due, up to the maximum allowed under state law. User agrees to pay reasonable attorney fees incurred, plus usual costs of collection and court fees, in the event of a default under this agreement. Persons signing on behalf of an organization or other entity assume personal responsibility for payment in full of all amounts due.
